Territory Overlap Agreement- Press Release

July 31st 2023 was a Celebration and Signing of a Territory Overlap Agreement by Two Superior Region First Nations - Biigtigong Nishnaabeg and Netmizaaggamig Nishnaabeg, Sets Precedent For Nation to Nation Relations in the Superior Region.



Netmizaaggamig Nishnaabeg, Ontario - - On July 31, 2023, leadership, and community members of Netmizaaggamig Nishnaabeg and Biigtigong Nishnaabeg gathered on the



traditional powwow grounds of Netmizaaggamig to witness the signing of an historic agreement between the two First Nations that was a result of years of hard work and commitment by leadership, legal and technical staff. A Territory Overlap Agreement is a partnership agreement that lays out the foundational working relationship for how each community would exist within each other's respective territories and well as work jointly in areas that overlap each territory. It will also strengthen the relationship between the two First Nations who work with collective visioning and strategies for conservation, development, sustainability and the protection of the lands, waters, and resources for future generations.

The ceremony included a traditional pipe ceremony and a water ceremony bringing together the waters of both communities. The signing of both an official Treaty and the Overlap Agreement by both Netmizaaggamig Nishnaabeg Chief Louis Kwissiwa and the Biigtigong Nishnaabeg Chief Duncan Michano Ir. being observed by youth, elders, and members of each community as well as invited guests, local regional Mayors, government representatives and Chiefs from the Superior Region was completed. There was an exchange of ceremonial gifts, wampum strings and pulling of beads between Chief Kwissiwa and Chief Michano, followed by a message and honor songs for next generations.



"This Overlap Agreement between Biigtigong Nishnaabeg and Netmizaaggamig Nishnaabeg is a testament to the effectiveness of our Anishinaabe diplomacy. Our two communities have worked well together, and this is another manifestation of our close relationship.

Chief Duncan Michano also states that "Biigtigong Nishnaabeg and Netmizaaggamig both understand the importance of respecting each other's ancestral territories. This agreement is a modern-day model of how our people co-operated with each other in the past so that they could thrive and prosper."



Celebrations topped off the event to bring together the two First Nations with community building games, social activities and food. Community members were also gifted seedling trees to take home to plant to honor the day and hopes for the future.



Biigtigong Nishnaabeg (formerly the Ojibways of the Pic River First Nation) is located off the TransCanada Highway 11/17, along the northern shores of Gchi-gaming (Lake Superior), adjacent to the Biigtig Zibi (Pic River). They are a vibrant and

progressive Anishnaabe community with a growing population. Biigtigong Nishnaabeg maintains a vision of growth and prosperity, continually striving toward diversified portfolios in mining, forestry, renewable energy, construction, property/land management, procurement, and sustainable development.

Netmizaaggamig is solidifying their reputation as a First Nation to build partnerships and meaningful relationships with Biigtigong, continues to advance their sovereignty through community strategic planning, stewardship, visioning and leadership.



Netmizaaggamig Nishnaabeg (formerly Pic Mobert First Nation) is located off the TransCanada Highway 17, along the eastern shores of Netmizaaggamig (White Lake). Netmizaaggamig means "First Lake from the Big Lake" (Gitchi-Gaming, Lake Superior). Netmizaaggamig Nishnaabeg's elders refer to Netmizaaggamig as a warehouse for food, medicines, and an important place for ceremonies. It is the heart of the territory and a core aspect of the community's



identity. They have been hunting, trapping, fishing, and caretaking their unceded title lands and waters since time immemorial and continue to do so today. Netmizaaggamig Nishnaabeg has a strong vision for its present and future socially, politically, and economically. Netmizaaggamig continues to Nation build and is part of a variety of projects that include forestry, mining, housing, land management and more. Netmizaaggamig Nishnaabeg pursues sustainable development that centers Anishinaabe law and values.

Community Health Fair August 2nd

Health Services hosted another successful health fair at this year's Community Week. We hosted several community partners such as Anishinabek Nation, George Jeffrey Children's Centre, Dilico Anishinabek Family Care, Marjorie House, and Thunder Bay District Health Unit's "Understanding Our Food Systems program. This year's fair was well received, as we had over 90 participants complete our Passport to Health.



We wanted to highlight some of our integral

partners, such as Nokiiwin & Dilico Health Services. These partnerships are integral to the care you receive here in the community. It was great to see the attendees engaging with service providers. Events like this create opportunities for our community members to learn first-hand about the services they can access.



Community members and service providers enjoyed a delicious hamburger and hot dog lunch together at the Pow Wow Grounds.



We are looking forward to next year's Health Fair. Finally, we would also like to say Chi-Migwetch to our Health Team for planning and preparing this event, to ISN for being excellent chefs, and to each and



every one of the attendees and participants for making it a memorable occasion.
